Immigration Executive Order

January 27, 2017

What is the Workforce and Student Mobility Impact?

On, Friday, January 27, 2017, President Donald J. Trump signed an executive order concerning immigration that bans citizens from specific Countries from entering the United States.

WHO IS AFFECTED:

- All citizens of Iraq, Iran, Syria, Somalia, Sudan, Libya and Yemen ("Countries") are prohibited from entry into the U.S.
- This includes all people who have lawful U.S. employment authorization or student visas and are seeking to re-enter the United States. If they leave the U.S., or left after January 27, 2017, they will be prohibited from re-entry into the U.S.
- *Developing:* Any permanent resident of the U.S. (green card), who is a citizen of any of the designated Countries, who was traveling outside the U.S. as of January 27, 2017, for pleasure or business, is presumed prohibited but may be waived for re-entry. Department of Homeland Security will review on a case-by-case basis to allow re-entry.
- Students at U.S. universities, from these Countries, who may travel home or out of country during school break or for study abroad curriculum are banned from re-entering the U.S.
- All businesses or universities employing or working with such individuals should evaluate the countries of citizenship, travel necessity and risk of any cross border travel before engaging in such activities.

WHAT IS AFFECTED:

• Any business and universities that work with citizens from these Countries will be affected. Work related travel, meetings, service calls, and other forms of physical mobility commerce will be restricted by the order, as well as students and staff at universities. Affected students may be prevented from returning to complete degree programs.

WHEN DOES THIS GO INTO EFFECT:

- The executive order went into effect, immediately, on January 27, 2017.
- There are federal court actions that challenge this executive order, but are, presently, limited to those people already detained at U.S. airports or in transit.
- The ban shall last a minimum of 90 days. After 60 days, a presidential proclamation will be issued identifying Countries whose foreign nationals will be prohibited from entering the U.S.

WHERE IS THIS AFFECTED:

• Worldwide. Any access point into the United States, which includes border points of entry and connecting flights.
